MINUTES OF MAY 2018 ANNUAL GENERAL MEETING

May 12, 2018 - 9:30 am - Wu Welcome Centre at Alumni Hall

Alumni Association President, Geoff Irvine '87 called the meeting to order at 9:32 AM. Quorum was established at 34 members present. Members presented were provided with an Annual Report containing; the proposed agenda, Minutes of the May 13, 2017 Annual General Meeting, Report from the President, Report from the Director of Alumni Affairs, Treasurer's Report, AAAU Constitutional Amendments 2018 – Proposed, and the 2018 Nominating Committee Report.

Adoption of the Agenda

G. Irvine asked for any additions to the agenda as presented.

<u>Motion:</u> Moved by Maxine McCuaig seconded by T. Upshaw that the agenda be approved as presented. Carried Unanimously.

Approval of the Minutes

The minutes of the May 13, 2017 Annual General Meeting were circulated to those present as content of the Annual Report. G. Irvine called for any errors or omissions in the minutes of the May 13, 2017 Annual General Meeting.

Motion: Moved by K. Power, seconded by H. Hickman that the minutes of the May 13, 2017 Associated Alumni of Acadia University Annual General Meeting be approved as circulated. Carried Unanimously.

In his opening reports G. Irvine referenced the contribution of the Wu family, in particular, in the establishment of the Wu Welcome Centre and the contributions made by our Alumni family in making Acadia University a better place.

G. Irvine invited Dr. Peter Ricketts to share greetings from the University.

Greetings From President Ricketts

Dr. Ricketts shared the fact that we are positioned for a great convocation weekend. It began with the Acadia Divinity Commissioning Ceremony last evening, highlighting the graduates' passion and commitment to their ministries. Dr. Ricketts noted the fact that the first 10 months of his term have been an enjoyable period focused on listening and learning.

The University is currenting in a position of stability resulting from the strong foundation left by the Ivany team. The Province has demonstrated its faith and trust in the organization. The changes on campus continue and the campus looks great. Collective agreements are now in place adding to the strong foundation. Dr. Ricketts

acknowledged the extraordinary impact made by the alumni. Dr. Ricketts referenced the newly launched strategic planning process and the fact that it is now time to build a solid plan for the future.

A highlight of the first 10 months was the opportunity to meet alumni throughout the world, providing an incredible part of the learnings. Dr. Ricketts spoke positively of the engagement of young alumni. Dr. Ricketts expressed a thank you on behalf of the University for the work and support of the alumni.

Dr. Ricketts invited the alumni to contribute to the new strategic planning process.

G. Irvine thanked Dr. Ricketts for his remarks.

Report from the President

G. Irvine thanked Ian Murray, Oonagh Proudfoot, Rod Morrison, Scott Roberts, Nancy Harrigan, Cassie Tremain and the other staff for their support.

G. Irvine referenced the Presidents' report as circulated, highlighting several items, including the progress achieved on various governance issues, the execution of the Memorandum of Understanding with the University, the branding exercise, awards program, student recruitment, the Grad Fair presence noting the efforts by Tony Stewart '72, the Bulletin and e-news. Over the past year, the Alumni Association was able to provide support to Athletics, the Student Union, Grad Class of '18, and the ASU Athenaeum.

Report from the Director of Alumni Affairs

- I. Murray welcomed the members to the AGM and noted the fact that 7 decades of Acadia Alumni were represented at this AGM. I. Murray acknowledged the attendance of Scott Grant '93 from TD Insurance Meloche Monnex, a valued affinity partner of the Acadia Alumni.
- I. Murray addressed the positive outcome from the 92 face-to-face events that took place in the previous year. These Acadia events were real opportunities to experience the remarkable impact that the many Acadia alumni make throughout the world. We are on the right track as we have seen a 20% increase in engagement and satisfaction. Several events, in particular, are worthy of note: the Presidents Gala for Ray Ivany, the Homecoming featuring the Caribbean connection, and Dr. Peter Ricketts installation.
- I. Murray thanked Geoff Irvine for his many years of service to the Acadia Alumni. He continued by thanking the staff for the support and effort and the contributions of Libby Burnham the Chancellor of Acadia University, as her term comes to an end this weekend.

<u>Motion:</u> It was moved by D. Jackson and seconded by K. Amos that the report from the President and the Report for the Director of Alumni Affairs be accepted as submitted. Carried Unanimously.

G. Irvine acknowledged the recent passing of Dr. Chris Olson, an Acadia alumnus, a great supporter of the Alumni Association and a key driver behind the establishment of the Music in the Garden program.

Treasurer's report

T. Walker presented the report on behalf of the Treasurer, P. MacIsaac. The Treasurer's Report, the Unaudited Statement of Receipts and Disbursements and Balance Sheet were included in the Annual Report to members. T. Walker noted the key objectives of the previous year and going forward are to focus on the financial reporting and investment management. It was noted that the Association concluded the 2017-2018 fiscal year with a surplus of \$88,460.

T. Walker on behalf of P. MacIssac thanked the members of the Finance committee for their efforts over the past year.

An opportunity was provided for members present to have any questions addressed.

<u>Motion:</u> Moved by D. Hovell and seconded by F. Gilbert that the 2017-2018 Financial Report be accepted as tabled. Carried Unanimously.

Constitutional Amendments

D. Davidson thanked the members of the Governance Committee for their efforts over the past year. The significant outcome of the past year's efforts of the Governance Committee and the Board of Directors has been the proposed amendments to the Constitution that governs our association.

The current constitution requires that the membership be provided with 90 days notice of any proposed amendment. The membership was advised though the notice of the AGM and through notice in the newspaper. The full text of the proposed constitution was made available to any member who requested a copy. A summary of the proposed amendment was included in the notice.

D, Davidson noted that these amendments will continue the journey of the Board of Directors to effectively represent the Acadia Alumni.

An opportunity was provided for members present to have any question addressed.

<u>Motion:</u> It was moved by D. Davidson, seconded by F. Gilbert that the constitution be amended as proposed by the Board of Directors. Carried Unanimously.

Nominating Committee Report

D. Jackson began his remarks by thanking the members of the Nomination committee, Hugh Bray and Charles Coll. A proposed slate of Officers and a proposed slate of Directors were tabled, as noted in the Annual Report.

D. Jackson called three times for nominations from the floor, hearing none, nominations ceased.

<u>Motion:</u> It was moved by D. Jackson and seconded by K. Amos that the proposed slate of Officers and Directors be approved as tabled. Carried Unanimously.

The outgoing Directors and Officers were thanked for their efforts: Kiersten Amos, Madison Cyr, Michele Gerrard, David Hovell, Doug Jackson, Amanda Penrice, Paul MacIsaac and Becca Webster.

New Business

The incoming President, R. Conrod thanked G. Irvine for his leadership over the past 17 years of service. R. Conrod noted that the fact the incoming Board of Directors is gender balanced and has representation from every decade from the 60's onward. R. Conrod acknowledged the solid foundation that is currently in place, providing the opportunity to move forward and he is looking forward to the next two-year term.

G. Irvine thanked those in attendance. There being no further business, the meeting was adjourned at 10:21.

<u>Motion:</u> It was moved by Tom Prescott seconded by D. Jackson that the meeting be adjourned. Carried Unanimously.

2018-2019 ANNUAL REPORT

From the President of the Association:

The Acadia Alumni Association has had a busy and productive year. The Alumni Association has benefited greatly from an engaged group of volunteer directors and a close relationship with the staff of the Office of Advancement. It is this group of dedicated volunteers and staff who have made all the efforts of the Alumni Association possible and I would like to take this opportunity to thank each of them for their hard work.

The Acadia Alumni Association Board of Directors met as a full Board on May 13 and October 13, 2018 and February 9, 2019. Our annual fall retreat was held in Wolfville during convocation weekend on May 13 -14, 2018. During the retreat, the board

integrated new members to the board, took part in strategic discussions with the University and discussed some of the priorities for the year.

The Executive Committee met monthly and the standing committees, including Finance, Governance, Communications, Awards, Young Alumni, and Nominations met regularly or as needed. Thanks to the committee chairs and committee members for the extra work they put into ensuring the Alumni Association's activities were successful. As you will see from the Treasurer's Report, the Alumni Association ended its fiscal year with a net positive income and in a very healthy financial position.

Key Alumni Association accomplishments this past year included:

- A significant financial commitment over the course of five years to support the Campaign for Acadia.
- Financial support for and co-hosting of a lecture by Dr. Jane Goodall in April 2019.
- A revised orientation program for new board members coinciding with the retreat and convocation weekend.
- Continued success in affinity programs that provide valuable services to alumni and grow the revenue of the Association.
- Re-establishment of the Outstanding University Service Award and also of the Isaac Chipman Award for Alumni Service, the later having been awarded to Bev Richardson ('60) during reunion weekend in the summer of 2018.
- Continued improvements to Governance practices and procedures, including a completed board evaluation assessment and report.
- Establishment of a Major Event Committee to research and plan a new event for alumni in the Halifax area. Funding has since been committed to this event which is expected to take place early in the Fall of 2019.
- Adoption of new by-laws for the Finance Committee, Nominating Committee, Awards Committee, Governance Committee and Executive Committee.
- Appointment of the following alumni to a 6-year term to the Acadia Board of Governors:

- Collaborating with the university on communication platforms for alumni including the "Alumni Bulletin", monthly e-newsletters and other social media;
- Providing financial support for key initiatives in student recruitment, athletics, the Alumni office, alumni programming and student activities.

Ian Murray '88, Executive Director of Alumni Affairs and Advancement Strategy provides a tremendous amount of support to the Association and is a wealth of knowledge for the Association. The Alumni Association Board deeply appreciates the

efforts that Ian and his team make for the advancement of Acadia's relationship with its alumni.

I have enjoyed working closely with Dr. Peter Ricketts over the course of the last year. The Alumni Association Board has had two opportunities to participate in the Strategic Planning Initiative being led by Peter and very much appreciated these opportunities to contribute to the University's future goals and ambitions. Peter has engaged with our alumni at events across the globe over the past year and has been a great supporter of the Alumni Association.

THE "BULLETIN" AND COMMUNICATIONS:

Two alumni magazines, meeting with very favourable feedback from members, were delivered last year – one in the spring and one in the fall. To supplement the information and updates shared in the "Bulletin", a monthly e-newsletter, chalk full of updates, invitations, and campus news was sent to all alumni for whom we have email addresses. In addition to the "Bulletin" and monthly e-newsletter, numerous emails were sent to either the full alumni family, or to specific segments of the family, sharing news or to promote an upcoming event or opportunity. All of these communication channels were underpinned by a more streamlined and contemporary set of web pages that were doggedly updated throughout the year. We continue to experience success in communicating with our alumni through our Facebook pages, as well as through Twitter and have become more active with Instagram communication over recent months.

ALUMNI RECORDS:

Maintaining accurate alumni records is an important function of the Alumni Affairs Office as it enables us to communicate effectively with our alumni worldwide. We consider an individual to be an "active alum" if we have contact information for them. We encourage all alumni to update their current contact information as we regularly use email, mail and the alumni "Bulletin" to inform our alumni about special events,

reunions and branch activities. We will often get mail returned to us because an alumna/alumnus has moved and has not forwarded a new address. If you know of someone who is not hearing from us and would like to, please encourage them to get in touch with the Alumni Office. Our extensive information management system allows us to manage each relationship with an alumna/alumnus as they would like. We are able to maintain current contact information for an individual, yet code them in our system to not receive email correspondence if they do not want to; to not be solicited if they do not want to, etc. Currently we sit at a total of 41,868 living alumni as of April 2019 (This includes those for whom we do not have contact information for). The total of active, alumni is 30,147. See breakdown below.

The fiscal year 2018-2019 was another positive year for the Acadia Alumni Association.

Our revenues continue to grow and our balance sheet continues to expand, in large part, due to our on-going association with our affiliate partners, and the generosity of our Acadia Alumni community.

Net receipts, this past fiscal year, totaled \$150,000 and net assets as of March 31 are \$1,424,000.

We will continue to monitor and review the Association's finances in order to ensure the funding of our on-going commitments. Equally as important, we want to ensure that future projects and commitments are financially viable through prudent stewardship of the Association's funds.

Christine also works as the Coordinator and Indigenous Pedagogical Leader for the Algonquin Inòdewiziwin EarlyON Child & Family Centre in North Hastings. Christine is an avid explorer of both the Algonquin landscape and Algonquin history, spending as much time on the land as possible. Her extra time is spent as an archaeologist, orator, author and researcher.

A 2011 Acadia graduate with a Bachelor of Arts in English and History, Christine's liberal arts education at Acadia University has not only encouraged a life-long love affair with Canadian literature and history but also taught her the value of critical thinking. At the end of her last year at Acadia, a professor encouraged the class to never take "truth" at face value but to dig much further, formulating an understanding based on all possible information.
